

# Winters Outdoor Quilt & Textile Art Festival

## Entry Criteria & Requirements

1. All quilts and textile art is eligible for display. All entries must contain fabric or fiber.
2. **Sleeves:** All entries must have a 4-inch hanging sleeve.
3. **Labels:** A label sewn to the back of each entry is required. The entry name and exhibitors name on the label must match the information on the Registration Form.
4. **Entry Fee:** A \$3.00 per item entry fee is requested. Entry fees (cash or check) must be turned in with completed Registration Forms. You may pay for multiple entries with a single check. (Make checks payable to “Cloth Carousel”.)
5. **Registration:** An original Registration Form is required for each entry. This form serves as the data for the show tag and must be completed entirely. The Story section is for interesting information about your entry and is optional (but we encourage you to complete the information).
6. **Photos:** A photo of the entry must accompany the Registration Form. Photos will not be returned.
7. **Liability Release:** Entries in the Winters Outdoor Quilt & Textile Art Festival are hung outdoors. Each exhibitor is required to sign a Waiver of Liability. An adult is required to sign a Waiver of Liability for any entrant under the age of 18.
8. **Insurance:** Insurance is the responsibility of the entry exhibitor/owner. In the unlikely event that an entry is damaged or lost, the Winters Outdoor Quilt & Textile Art Festival, the City of Winters, the Winters Chamber of Commerce, and Cloth Carousel will not be held responsible.
9. **Photography:** Entries may be photographed by show attendees and the media, but photos may not be used for commercial purposes without the written consent of the exhibitor. Submission of an entry to the Winters Outdoor Quilt & Textile Art Festival constitutes consent by the entry owner to allow it to be photographed.
10. **Claim Check:** Claim Checks will be issued when entries are dropped off, or kept on file for entries that are shipped. Identification may be required to pick up entries. Please pick up your entry after take down beginning at 4:00pm on the day of the Festival. **No entry will be released without a Claim Check.**
11. **Items for Sale:** The Winters Outdoor Quilt & Textile Art Festival handles all sales and retains a 20% commission. Checks for items sold will be mailed within two weeks of the Festival date. Entries entered for sale must adhere to copyright law.

**Please read carefully and sign the following waiver to complete your entry.**

The Winters Outdoor Quilt & Textile Art Festival (“We”) will handle your entries with diligent care and will watch guests to prevent them from handling the entries. We foresee no harm to befall an entry and are confident in maintaining your trust. Nevertheless, we cannot accept financial responsibility for anything that may happen to the property of entrants. Therefore, we ask all entrants to sign the following statement to evidence their recognition and assumption of risk.

### Waiver of Liability

**I expressly agree to release the respective agents and members of the Winters Outdoor Quilt & Textile Art Festival, the City of Winters, the Winters Chamber of Commerce, and Cloth Carousel from all liability for loss, damage, theft, injury, or destruction to any article entered by me in the Winters Outdoor Quilt & Textile Art Festival. I understand that I bear and agree to assume the risk of loss to my property and that it is up to me to properly insure my property against any or all risks of loss, if I so choose.**
